DISPUTE CERTIFICATION FORM as required by O.C.G.A. § 50-27-102 (d)

PURPOSE OF DISPUTE CERTIFICATION FORM: The Dispute Certification Form is to be completed by a COAM license holder to certify whether or not a dispute exists with another current or former COAM license holder. This Form may be used by a location license holder seeking to have COAMs removed from its location or by a master or location license holder wishing to bring a dispute with a current or former license holder to arbitration. This Form may also be used by a master license holder seeking to relinquish a location by certifying it has no dispute with the location license holder.

INSTRUCTIONS FOR COMPLETING DISPUTE CERTIFICATION FORM: This Dispute Certification Form **MUST** be completed, signed and emailed to COAMReporting@galottery.org. Submission of Dispute Certification Form by any other method shall not be accepted by the Georgia Lottery Corporation (GLC) as official notification. Failure to follow these instructions may result in the denial of your dispute. Location License Holders shall not complete and submit forms on behalf of Master License Holders and Master License Holders shall not complete and submit forms on behalf of Location License Holders.
